This offence is punishable by a fine of up to £5,000 and/or disqualification as a councillor for up to five years.

Section 30 of the Localism Act 2011 defines Disclosable Pecuniary Interests. You are required to disclose your own Disclosable Pecuniary Interests as well as any Disclosable Pecuniary Interests of your spouse or civil partner or anyone you live with or are in a relationship with akin to a spouse or civil partner (collectively called "your partner") which are known to you.
